

Process over an 18-month period (late 2019-mid 2021)



Programme Strategy & Priorities

Overall rationale

"Improving regional development policies (including Investment for Jobs and Growth programmes), through exchange of experience, innovative approaches and capacity building"

Structure of the programme

Priority: Interreg Specific Objective1: a better cooperation governance

Specific objective: enhance the institutional capacity of public authorities and relevant stakeholders

80% of funding (indicative)

Smarter Europe Greener Europe More social Europe:

labour markets, health care, culture and sustainable tourism

20% of funding (indicative)

More connected Europe Europe closer to citizens

More social Europe:

education, social inclusion, integration of third country nationals

Target groups

Core target groups: policy responsible organisations

- National authorities
- Regional authorities
- Local authorities
- Other bodies responsible for regional development policies

Other target groups: actors relevant to regional development policies Examples:

- Business support organisations
- Environmental organisations
- Education and research institutes

These target groups and any other relevant actors (SMEs, for example) can also be involved in projects through **regional stakeholder groups**.

Eligible beneficiaries

No changes compared to 2014-2020

- Public authorities
- Bodies governed by public law
- Private non-profit bodies

"To improve through exchange of experience the implementation of the regional development policies of the participating regions"

Policy Learning Platform

"To facilitate policy learning and capitalisation of the regional policy good practices on an on-going basis"

- Particular focus on improving Structural Funds programmes
- Two phases
- Mandatory action plans



- Pilot actions only in phase 2
- Stakeholder groups


- 'Lighter' focus on Structural Funds programmes
- Core phase + follow-up phase
- Action plans only when needed
- Pilot actions possible from the start (learning by doing)
- Stakeholder groups

Conclusion: no revolution...

Key features remain

- Pan-European
- Overall objective
 - ✓ Improving regional development policies
 - √ Policy responsible organisations as core target group
- Means to achieve the objective
 - √ Focus on capacity building

.... but evolution

- 1. One single priority in the programme
 - Better reflect the core nature of the programme (capacity building)
 - Scope of the programme enlarged
- 2. Lighter focus on Structural Funds
- 3. Learning by doing facilitated (pilot actions)
- 4. Platform services open to further development
