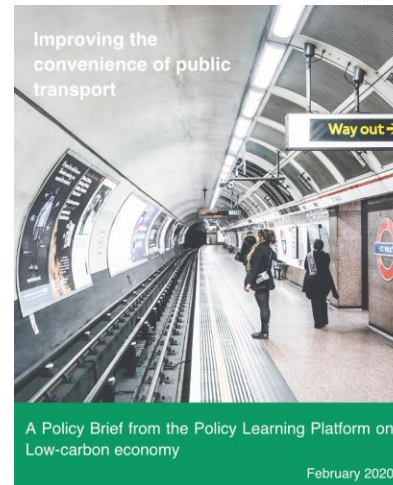

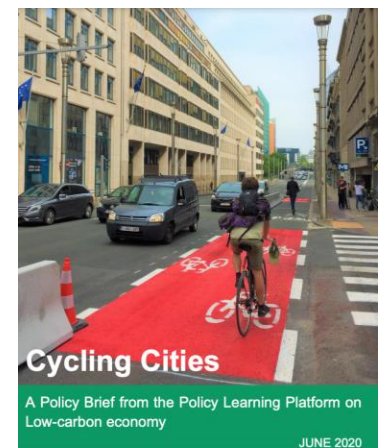

Motivation of the host

Reaching climate neutrality by 2050, as is set out by the EC's Green Deal, requires timely decarbonization of the energy sector, including a phase-out of coal. The transition towards a low-carbon economy poses significant technological, economic and social challenges, in particular for coal-intensive regions, as is the case with the Western Macedonia Region (RWM). In its revised National Energy and Climate Plan (NECP), the Greek Government has committed itself to the full closure of all lignite-fired power plants by 2028.

The case of Western Macedonia is a unique example of such an intensive economic transition, at a time when the region is already facing exclusive problems of unemployment, ageing, migration and low

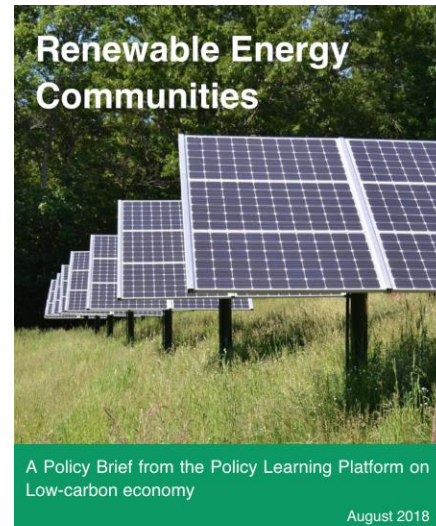

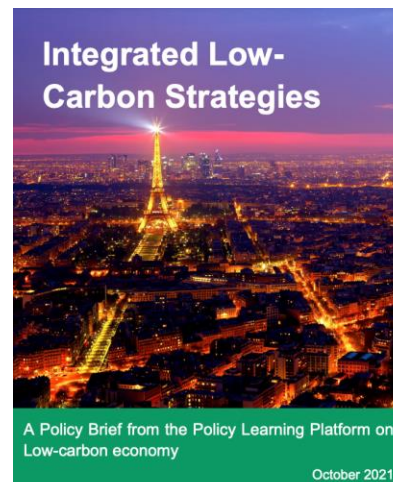
