

FUNDAMENTAL FUNCTIONS OF COORDINATION AND NORMATIVE SUPPORT

Going a little further in detail, such a center of competence is called in any case to ensure:

- regulatory and jurisprudential monitoring and consequent updating of the reference structures;
- legal support in the branches of law listed above, as well as in matters relating to the Single-Business-Office (SUAP), compliance and procedures relating to individual economic activities attributable to the scope of the SUAP itself and related proceedings, first and second degree, to regulatory activities and, now, to control activities;
- homogeneity of the operating procedures and procedures, as well as the interpretation of the regulations governing economic activities;
- determination of the information content relating to the formalities and procedures to be published on the institutional reference portal and preparation of the forms (static and dynamic);
- identification of the measures necessary to guarantee the transparency of the administrative action and the streamlined procedures;
- overseeing the measures of privacy and the right of access with respect to what is contained and published in the databases;
- interaction with the level of planning and planning for the purpose of adjusting the system to regulatory developments, the evolution of the current system components, the creation of new functionalities and the management of information systems interfaces;
- continuous training;
- prevention and management of litigation.
