





- By improving RIS3 implementation effectiveness;
- —> in what way? by investing in relatively or totally new products (Oslo manual)
- An innovation strategy, to be implemented, is applied to a regional context
- A regional context, in the case of implementation of an innovation strategy is a regional innovation system. Development Fund
- A regional innovation system relies on 1) institutions/actors, 2) the interactions among them, 3) appropriate knowledge of the actors (map below)
- Some times this regional innovation system is not working well, it is missing something. This something we try to bridge through interregional complementarities and good practices.(next slide)



Purpose of IWG2



 For regional authorities to understand better each other's and own context and probably identify ways of cooperation that solve key development issues in their respective areas.

How IWG2 is linked to the action plans

- The action plans have four "actions" (AC): AC1,AC2,AC3,AC4. Each action is linked to good practice themes:
 - AC1: Industry led centres of competence as RIS3 innovation infrastructures
 - AC2: Combination of funds
 - AC3: Combination of funds with interregional eligibility: Interregional complementarities and tools to support AC4 above.
 - AC4 research to- business investments. AC4 concept: collaborative type of projects, example: eligible to submit co funding application (2 businesses from one region, 1 research institution from the same region, and 1 research institution from another region (ideally the advanced region)).
