HIGHER Innovation experience hub

The project will launch early 2018 learning paths about innovative public procurement as a tool for innovation in the public administration and Smart Specialization Strategies. In particular, the didactic units will focus on topics like legal framework at European, National and Regional level, experiences carried out in the activation of innovative public procurement procedures, approaches to innovation and regional specializations and worst and best practices.

The lessons will be addressed to people employed in public administrations and in and in private businesses, university students from technical, scientific and legal faculties, anyone interested in enhancing knowledge on innovative concepts.


The contents will be available on the MARLENE (MarchE-Learning Network), and platform owned by the Marche Region and open to all citizens for online training upon registration.



Smart Specialisation Map

HIGHER project is working to capitalise an online tool called Smart Map, developed by UAB Research Park and Marche Region in the scope of CITEK project (cofinanced by the MED Programme) and related to RIS3 drawing up and implementation monitoring. The Smart map will be an interactive map aimed to provide a complete overview of the RIS3 plans in, at least, regions involved in the project (Catalonia, Marche, Abruzzo, Central Macedonia, Cambridge, North Portugal, Stocolm, Slovenia, Greece, Slovenia and Lituania), using Google Maps technology.

This tool will allow the user to filter regions according some criteria, including the key enabling technologies (KETs) and economic sectors in which a region aims to specialize. Given the relevance of connecting different regions (and their stakeholders) European-wide, this instrument becomes very useful when detecting which territories are developing innovative activities in the same sectors, looking to promote synergies among them to design and implement further projects.



Good practices collection of Smart Specialisation

The development and implementation of smart specialisation strategies can be a complex process; the HIGHER Good Practice Collection on Smart Specialisation is, therefore, designed to provide innovation stakeholders with an overview of good practices in the design and implementation of smart specialisation. The aim of the Collection is showcase different good practice examples from the HIGHER Partnership and other European regions, focusing on how to overcome some of the most common challenges faced when facilitating the smart specialisation process under four key themes: The Entrepreneurial Discovery Process, Good Governance, Transnational Cooperation and Value Chains and Monitoring and Evaluation.
