#### **Almada City Council**



How do you evaluate RESOLVE's first 2 years? What have you learnt so far?

We evaluate very positively the first 2 years of the RESOLVE project. In particular, the Exchange of Experience activities have been very interesting and useful for Almada, because it allowed us to identify and learn more about several good practices that might be replicated in our Municipality. The Peer Review in Almada that was organized in the framework of the project was also a great opportunity to provide the Local Authorities "outside" Stakeholders with perspective, which allowed us to see some aspects of our mobility strategy in a different way. The Peer Review will be important to deepen the work of the City Council the development of its SUMP.

#### **Maribor Municipality**



How do you evaluate RESOLVE's first 2 years? What have you learnt so far?

The first 2 years of Maribor Municipality cooperation in RESOLVE project brought several stakeholders together to discuss and search for solutions regarding the reduction of carbon emissions in the city centre with commercial area and pedestrian zone. We learned about good practices during the study visits in partner cities such as Almada and Reggio Emilia in particular in the field of public transport in the city centre, pedestrianization and cycle path network. In April 2017 Maribor organized the Peer Review where a team of experts from Netherlands, Czech Republic and Sweden discussed retail related traffic and revival of old city centre with participants from municipal departments.

### Resolve enters the next stage

We are approaching a pivotal moment in the life of the project. More specifically, we are moving from the learning phase to the planning phase! In the first 18 months project partners have mostly focused on acquiring new knowledge. Firstly, they assembled the Register of Good Practices to get to know which projects and/or policy measures might be interesting for them. Secondly, they hosted the Peer Reviews to assess their strengths and weaknesses of their actual policies. Next, they performed local surveys to set the baseline measurement for the policy measures they are going to implement later on. Finally, they started a series of Study Visits to allow the Local Stakeholders Group to get more familiar with specific measures.



In 2018 the project is moving to the next stage: planning! Besides finishing the remaining Study Visits, project partners will perform two main activities in the next period: organize the Import Workshop and produce the Regional Action Plan (RAP). They will start with reviewing the progress, plans and problems so far to, next, prepare an outline for their RAP. After that, they will hold the Import Workshop, where local stakeholders and relevant experts (some might be the same experts had during the Peer Review) will discuss the draft RAP. The RESOLVE project aims at finalising the RAPs by the end of the year.
