Introduction

The HoCare project team of Lithuania (Lithuanian Innovation Centre) organized an internal meeting with the aim to present the draft Action plan and get comments and proposals for improvements from colleagues and to inform about the upcoming event – HoCare 4th steering group meeting and all project partners meeting on the 22nd-23rd of March in Vilnius where the Action plan will be presented for all partners of the project. It was also planned to set a dare for the 4th internal meeting and 4th stakeholder group meeting.

The meeting was organized in Vilnius (Mokslininkų str. 6A), in the office of Lithuanian Innovation Centre.

CONTENT OF THE MEETING

Mr. Edgaras Leichteris, who was assigned responsible during the last internal meeting for the delivery of the Action plan presented a draft version of the Action plan for Innovation Vouchers (further – Innovouchers) with the aim at fostering Home Care innovations in enterprises working with health services. He presented the chosen good practice that has a potential to be transferred – the Bulgarian Applied Technology in Health service practice creating advanced services to support the prevention, diagnostics and treatment of deseases with pronounced social sighnificance. He suggested that such practice could be implemented in Lithuania by Lithuanian SME "Poilsis Druskininkuose" which is focusing on accommodation and health services and has an ability to obtain necessary equipment as well as know-how to provide home care services.

During the discussion Mr. Sigitas Besagirskas suggested to include another possible good practice in the Action plan – the system for real time patient vital signs observation, regarless of location of the patient, which was developed successfully by the Bulgarian company "Checkpointcardio". After the discussion about this good practice it was agreed that Mr. Edgaras Leichteris will include this in the Action plan and will find an organisation which could be interested in implementing this good practice in Lithuania.





During the meeting Ms. Ingrida Tinfavičienė informed colleagues of the upcoming all project partners meeting in Vilnius and shortly informed about main main activities of the 2nd phase of the project. She informed that during the meeting all partners will present their Action plans and there will be a possibility to have individual consulation with project lead partners and other partners. Also, she pointed out that there will be status of the project, main results and 2nd phase of the project discussed. Talking about the next steps of the project activities she emhpasized that during semesters 5, 6 and 8 must be regular updates made of the project website with information on the action plan implementation and that during 7th semester there will be a final dissemination event with policy makers involved with the aim to disseminate the results of the action plan implementation.

After the presentations and disscusion it was decided that Mr. Edgaras Leichteris will supplement the Action plan with another good practice and will present the Action plan during the all project partners meeting on the 22nd of March. It was also decided to make another internal meeting and stakeholder meeting after the all partners meeting in the end of March to present the updated Action plan and to get feedback from stakeholders. The date for both events was set on the 26th of March – to organize the internal meeting in the morning and stakeholders meeting during the second half of the day.
