1. MINUTES of the LSG Workshop


a) Good practices: open discussion and examples emerging from the local level

The third stakeholder meeting in the frame of the project "Sustainability of the Land-Sea System for Ecotourism Strategies" was held on 10th of May 2017 at 14.00 in the conference room of Regional administration Varna. The meeting was attended by representatives of: Regional Inspectorate for Environment and Water – Varna, , Project Troy Ltd., Municipality of Valchi dol ,Varna Association of Restaurants and Hotels,Directorate Golden Sands, Varna Industrial Association, Municipality of Dalgopol, Municipality of Byala, Municipality of Aksakovo, Varna Archaeological Museum as well as the members of project team management.

Mrs. Silvia Stoylova (Secretary General of Regional administration Varna) as well as Mrs. Velina Georgieva, the project manager, opened the meeting and welcomed the participants. They introduced the agenda and the main purpose of the today's workshop. A short introduction of the project was made: Regional Administration Varna is a partner of Land-Sea, Interreg Europe 2014-2020, whose main objective is to promote inclusive and efficient regional governance processes to increase and motivate the creation of knowledge and skills for the development of a sustainable ecosystem in the region that can preserve natural habitats, cultural and natural heritage and stimulate territorial growth. The action plan has to propose all possible measures to prevent the most pressing problems in the field in order to change the OP financial instrument for the period 2021-2017 and to allocate resources for solving infrastructure problems in the area - landslides, erosion, floods and others.

Improving the OP instrument can be achieved by:

- Linking projects for the protection and promotion of cultural and natural heritage with plans and methodologies for coastal zone protection;
 - Risk assessment through mapping and development of tools for monitoring cultural and natural heritage;
 - · Early warning and conservation measures
 - · Creating green jobs in tourism





Creation of integrated ecotourism products, and others

After a short discussion regarding the action plan, all attendees united around the idea for participating and the meeting continued with addition questions:

The Mayor of Dalgopol: We support the proposal and each of us to provide the necessary information and experts from each municipality.

The Mayor Provadia: For our municipality we will bind the Ovech fortress as a tourist product in one with the necessary infrastructure measures.

Mrs. Silvia Stoilova: It is possible to make a proposal for accessibility and environmental friendliness to Karajere beach for the Municipality of Byala.

Mrs. Velina Georgieva: We will set up a working team of: project experts, stakeholders, experts from the municipalities, and we will prepare a schedule to visit the sites and express a competent opinion and the necessary measures.

After a discussion, all attendees united around the idea:

Proposals for infrastructure changes, research, etc. will be submitted by the end of June. measures, as well as the necessary finances, which will form part of the action plan aimed at changing the financial instrument. Provide dates that are convenient for a business visit to each municipality, make a run-in timetable to perform expert judgment on how to solve the problems.






