
End 18th century: urbanization





Introduction

Legislation :

- Soil Remediation Act of 22 February 1995
- Soil Act of 27 October 2006

Aims of the Soil remediation Act

- To deal with soil contamination that has taken place in the past, over a period of 40 years, starting in 1996
- To prevent or immediately remedy new soil pollution

USA: RCRA 1976, CERCLA - Superfund 1980

EU : no Soil Directive nor Soil Framework

Brownfield covenant Act

March 22, 2007

Definition of brownfield :

A Brownfield is the whole of neglected and underused grounds, which have been affected in a way, that they only can be reused by means of structural measures.

a facilitating framework for the redevelopment of Brownfield sites.

- former **abandoned or under-used industrial site**
- (perceived) soil contamination
- redevelopment is a complex process
- active potential for reuse



Brownfield covenant Act

March 22, 2007

Advantages :

- single contact point (Agency for Entrepreneurship)
- negotiator appointed by the Government
- guided participation process
- **integrating multiple governmental permits**
- follow-up and monitoring by steering committee
- tax reduction (10%) at land acquisition
- no financial guarantee on soil remediation
- **covenant : signed agreement**



Results (June 2018) :


- 8 calls -> 190 proposals introduced
- 82 signed covenants
- 1.500 ha redeveloped

Process



Policy initiatives 2017

7th call on brownfield projects

Specific emphasis on :

- brownfield project includes redevelopment of former landfills;
- landfill is at least 75% of project area;
- take into account : waste volume, surface conditions, environment and policy:
 - ELFM²;
 - valorisation of landfilled waste (WtM, WtE);
 - remediate landfill to sustainable valuable land use;
 - define protection measures;
 - exchange of experiences;

combined with new park area (12 ha)




Brownfieldproject Power station

Communicatie en brownfields

Aandachtspunten bij de communicatie rond complexe projecten zoals Brownfield herontwikkeling:

- Timing (langdurig proces, interim gebruik)
- Diversiteit van het publiek accepteren (Nimby, Banana, Cave)
- Juiste verwachtingen scheppen (Expectations)
- Onduidelijkheden vermijden (avoid ambiguity / Risk management)
- Complex zaken niet uit weg gaan maar toch verstaanbaar maken




Nimby : Not in my backyard

Banana : Build Absolutely Nothing Anywhere Near Anyone

Cave : Citizens Against Virtually Everything
