Empower News on Technical Workshops

Two countries hosted a Technical Workshop, providing an opportunity for partners and stakeholders to learn more and increase their knowledge on Energy and financial monitoring. Both workshops topics were crucial in consolidating the learning process among project partners. Experts invited from project partners will assist them and their regional stakeholders to import their good practices into policy in each region and prepare their Regional Action Plan.

Technical Workshop "Energy monitoring, regulation and management"

The first workshop was focused on Energy monitoring. It was organized in Costa da Caparica on 24th and 25th of October 2018 and hosted by AGENEAL for around 35 attendees. This event was focused on energy monitoring, regulation and management and among the participants were local and international experts in this field, invited by the project partners. The agenda for both days of the workshop included the presentation of several good practices and in-depth debate on technical, financial and social issues linked to the topic of energy monitoring and management in public buildings.

The main objective of all presentations was to reduce energy consumption and thereby to reduce carbon dioxide emissions. Within the workshop EMPOWER project also joined forces with another European project named QUANTUM to reduce energy consumption in buildings. <u>More</u>



Workshop - Innovative Financial Instruments in Magdeburg

The second Technical Workshop was oriented on Financial Instruments and was organized in Magdeburg on 4th and 5th of December 2018, hosted by Development Bank of Saxony-Anhalt.

The EMPOWER technical workshop gave partners a chance to cooperate in creating innovative financial instruments while benefitting from experts opinions from all the partner regions. The workshop kicked off with an overview over the European framework for financial instruments, presented by the managing authority for ERDF and ESF in Saxony-Anhalt. Next, the partners got to know several existing financing models which are already being applied today. Experts from Sweden, France, Spain, and Germany presented detailed insights into concrete examples for uses of Green Impact Bonds, the European Regional Development Fund, European Structural and Investment Funds, Crowdfunding and Energy Performance Contracting. Last but not least, there were two presentations from "a banker's perspective" which elaborated on banking criteria for funding energy efficiency projects. More









After Energy and Financial Monitoring Workshops good practices will be imported into policy in each region through Regional Action Plans which will be produced by each partner.

Empower Project Management Group Meeting #4

On 23th October 2018, AGENEAL, Municipal Energy Agency of Almada hosted EMPOWER partners for the fourth Project Management Group Meeting (PMG4).

Partners were welcomed by Vlasta Krmelj, lead partner of the project. This 4th meeting was the occasion to monitor what the Project partners has done so far and to share and plan many important actions and further steps to be implemented in the next months. Partners have actively exchanged information, news, views and experiences on working during the last 6 months in EMPOWER.



Empower enters the next stage

Empower partners are moving to the phase of preparing Regional Action Plans.

In the last months project partners were focused mostly on Peer Review and lessons learned from the Study visits. A series of Study Visits were hosted to allow the Stakeholders to get more familiar with specific financial and energy monitoring measurements. The Register of Good Practices was prepared and adopted. Two Thematic Technical Workshops have been organized, one led by Almada, Portugal on Energy Monitoring and a second led by Saxony Anhalt, Germany on innovative financing of energy projects.
