ACTION 1

1. **The background** (please describe the lessons learnt from the project that constitute the basis for the development of the present Action Plan)

During the eco-innovation research cross visits, Devon County Council were introduced to a cooking education project in Ferrara, Italy; 'Activ Ecolab', which we would like to base some further work with communities / households on.

2. **Action** (please list and describe the actions to be implemented)

We would like to run a comprehensive Devon-wide Citizen Food Waste Prevention (CFWP) programme of practical cookery workshops teaching people how to reduce food waste through thrifty cooking. Delivery of this project will be subject to accessing suitable funding. We have prepared a pilot action request for Interreg funding and are awaiting a decision on this proposal tbc by the end of February 2019. For full detail on the proposed action please see the pilot action request and associated budget which we attach as Appendices to this document. Working title for the project is 'Clever Cooking'.

3. **Players involved** (please indicate the organisations in the region who are involved in the development and implementation of the action and explain their role)

Devon County Council – Project Officer to coordinate the project including logistics, budget and technical aspects and advise/train Community Food Workers on key Love Food Hate Waste behaviours

Devon households – to attend the workshops and cascade knowledge, skills and experience

Community Food Workers – to deliver the programmes of workshops

Devon schools / town councils / communities – venues, publicity, attendees

WRAP's Love Food Hate Waste CFWP campaign – key behaviours, knowledge, understanding and ideas of how to reduce food waste.

4. **Timeframe**

To be delivered April 2019 – March 2020 and beyond, if successful, subject to the designation or grant of further funding.

ACTION 2

1. **The background** (please describe the lessons learnt from the project that constitute the basis for the development of the present Action Plan)

Our own regional research and increased understanding of the position of local stakeholders has determined that there are gaps in capacity to redistribute surplus food from throughout the supply chain across Devon and therefore potential to increase the amount of surplus food that is redistributed. There are many ways in which we could have approached increasing surplus redistribution. One of the ideas that we came across during our own regional research was the [Community Fridge](#) concept and we think that this idea has the most potential within our context – particularly given it deals with household alongside commercial surplus.

2. **Action** (please list and describe the actions to be implemented)

Develop a partnership project to increase the infrastructure/availability/awareness for/of surplus food redistribution across Devon via a network of new Community Fridges (chilled space) and Larders (ambient space) in order to enable access to the numerous sources of surplus that exist – both from local producers and retailers and also from households. We have done some further work to develop this project as part of an External Funding Project Proposal which we attach as an Appendix for further information. Working title for the project is 'Food Freedom'.

3. **Players involved** (please indicate the organisations in the region who are involved in the development and implementation of the action and explain their role)

4. **Timeframe**

Develop a partnership project and gain external funding to deliver this project from 2019-2021

5. **Costs**

£150,000-£200,000 – further detail in the External Funding Project Proposal Form attached as an appendix.

6. **Funding sources**

The funding for this project will need to be accessed via an external grant. We are aiming to win funding from either the National Lottery's Partnerships or Reaching Communities Fund. The outcome of this funding process will not be known until April / May 2019 during Phase 2 of the ECOWASTE 4 FOOD project.
