Action 1:CE– IS concept in calls

Background: emphasized need for legislation fostering circular economy initiatives

Action: analyzing the legislative background, making proposals & „circular” EDIOP calls

Pre-study as a starting point (TRIS)

Cost of action: 10 000 EUR

Funding source: IFKA’s other international project and own operational sources

Action 1:CE– IS concept in calls

Progress:

1. TRIS proposal sent to Ministry for Innovation and Technology – Department of Business Development: 3 meetings held

2.1: EDIOP 4.1.4-19 call: circa 62 millio euro – closed in January 2020; evaluation in progress
aim: to increase energy efficieny using biomass

2.1 and 2.2: New program for SMEs- 12 million euro
green concept – boosting energy- and material efficiency,
proposal worked out in TRIS will be integrated
call will open: in 2020

Action 2: Green Public Procurement



Background: public authorities = major consumers (**16% of GDP**)

Action: analyzing the legislative background in Hungary, making a regional comparison → DOP, policy proposals and long term cooperation

Pre-study as a starting point (TRIS)

Cost of action: 20 000 EUR

Funding source: GREENIN project (GPPI focus) and others

Action 2: Green Public Procurement

GREENIN project (H2020 – international - GPPI focus)

successfully implemented

1 year – until 2019 Oct 3 dissemination events held

Design Option Paper created and sent to

Hungarian stakeholders

Climate-KIC: CLIMEV-GPP project – Hungary-specific work

from July 2019 – Dec 2019

thanks to TRIS project IFKA was involved

→ **GPP working group invitation** to contribute to policy development (work is still on going, not widely communicated so far, the progress should be discussed with a larger audience approximately somewhen bw. late spring and autumn)

Action 3: Dissemination

- IS concept through info days related to EU funds
 - No info days – but volunteering email sent to the Authority (one inquiry to make a presentation so far via phone the day before the skype meeting)
- IS workshops for SMEs_clusters
 - Joint project proposal with Archenerg cluster – on the topic of circular construction sector (IS options)
 - 28 Oct 2019 training held to businesses – TRIS project was presented (34 participants)
 - EUCalc event for SMEs (31 participants)
- Join the most relevant nationwide circular economy initiatives – be an active promoter
 - Circular Economy Platform – meeting participation
 - Joint project proposal with BCSDH (initiator of the Platform)

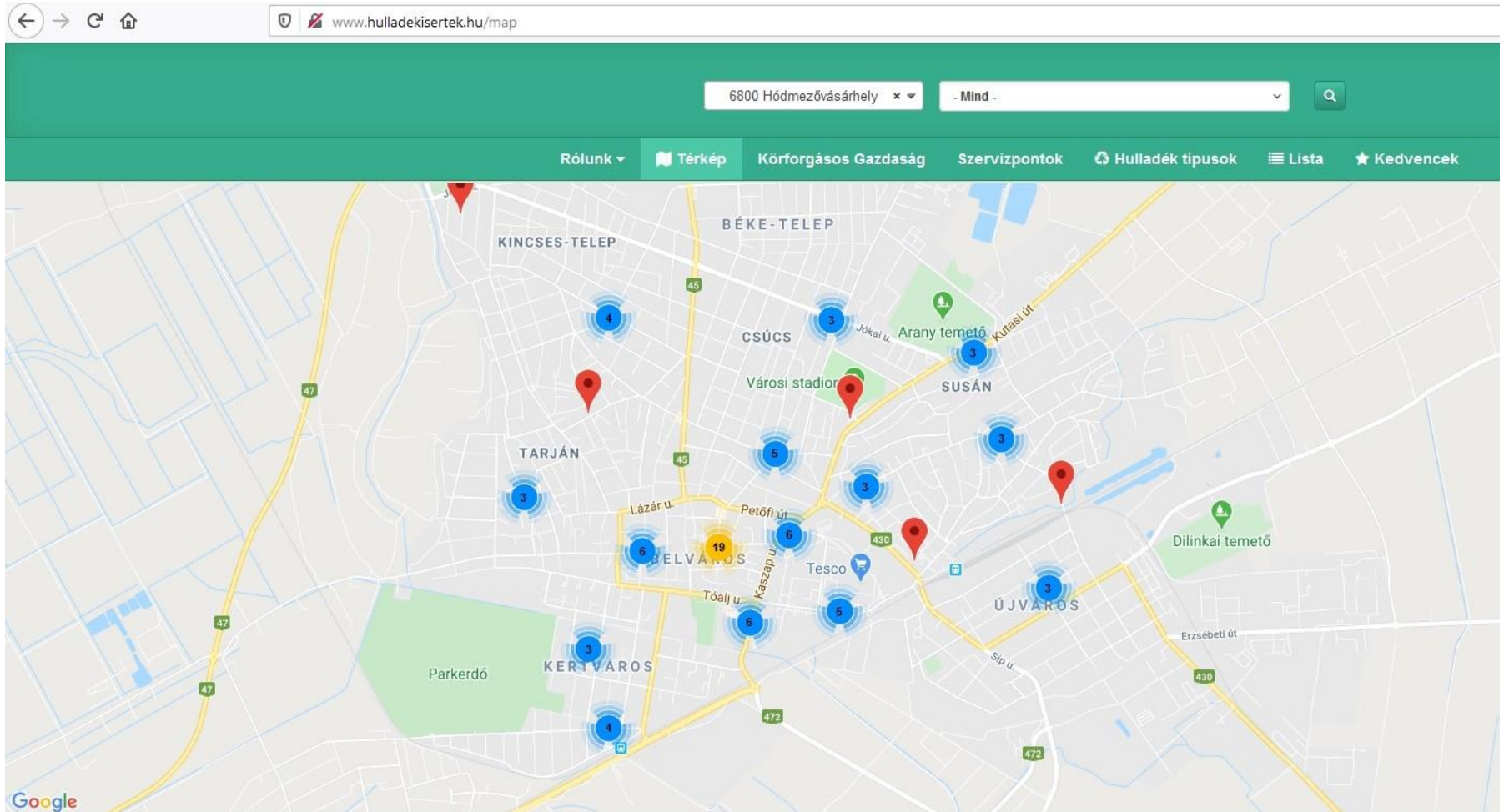
