If such action(s) are agreed, they will also be part of the ITHACA Action Plan. A presentation on the ITHACA project was made addressing key relevant areas of ITHACA learning. The meeting concluded that a new round of consultation was required to pursue project ideas considered the most relevant in the context. One of the most important of these areas was eHealth. Thus, Region Zealand could potentially benefit considerably from the experience of other partners who have worked extensively in this area.</p>
