Without surprise, WINPOL flew through areas of turbulences due to the COVID-19 pandemic, like many others. Waste has been one of the sectors directly impacted by the situation, having to deal with questions such as how to manage waste from household with COVID-19 (or suspected) cases, how to protect the health and safety of waste workers, how to comply with social distancing measures while maintaining waste collection, ... As a consequence, most of the WINPOL partners had to adapt their activities and more generally their systems to continue to provide this essential public service to their citizens. At the same time, some activities critical to the exchange of experience at the heart of the project got cancelled: no more study visit to Bergen and its pneumatic collection system, no more events at local level, no more seminar in Heraklion...

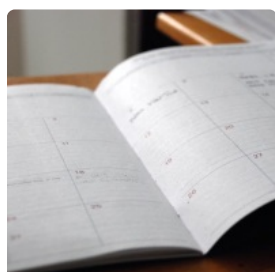

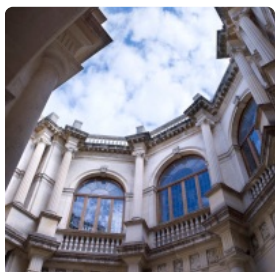
What is so far the impact of WINPOL at local level?

Exploring PAYT and KAYT with LIFE RETHINKWASTE

If pay-as-you-throw is nowadays a known model of waste generation fees, few are aware of its counterpart, know-as-you-throw. A seminar explored these two ways of designing municipal tariff systems in order to improve waste governance. Cities like Berlin, Bergamo, Miglianico or Lousada shared their experiences and discussed taxation and awareness-raising to improve separate waste collection. [More](#)



What are the costs and benefits of improved paper and packaging waste collection?

It is possible to achieve high performing separate collection of paper and packaging waste (PPW) while maintaining acceptable fees for citizens, a report of the COLLECTORS project found. However, local authorities are largely dependent on national incentives. So how to guarantee that investing in improving PPW collection system will impact costs

positively? COLLECTORS performed cost and benefit analyses of several case studies to bring a first answer to this question. [More](#)

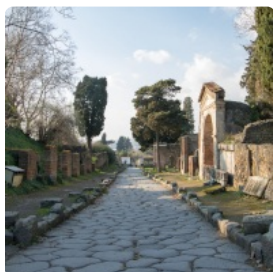
Have you seen these resources and tips shared by Interreg Europe?
