WHAT IS INNOCASTLE?

Innocastle is an Interreg Europe funded project focused on improving policy instruments governing Historic Castles, Manors and Estates (HCME) in four partner regions from Romania, the Netherlands, Belgium and Spain.

Each partner will develop an action plan to improve their policy instrument.

The National Trust from the UK will act as knowledge partner throughout the process and support all partners in remodeling their policies.

WHAT DOES IT MEAN IN PRACTICE?



BASELINE SURVEY

All partners will analyse the policy instruments in-depth, based on a joint methodology. Several learning cases will be selected in each region.

SPECIFIC OBJECTIVES



GOVERNANCE AND PARTNERSHIPS

INNOCASTLE increases crosssectoral governance (local, regional, national, European levels) and collaboration (public, private, research and society sectors). It also facilitates transdisciplinary partnerships (heritage, tourism, leisure, landscape) and works on regional development priorities (a.o. climate and fragmentation).



FINANCE AND INVESTMENTS

INNOCASTLE generates know how on meaningful, integrated and durable transformation of HCME and sustainable business models. Key themes are taxation systems, subsidies systems, and regional economy and business cases.



STUDY VISITS

Partners and stakeholders will visit each partner region and exchange best practices.

Different thematic topics will also be explored during the visits.



PROMOTION AND VISIBILITY

INNOCASTLE assists with branding & communication actitivites and develops know-how for local and regional actors to better promote and facilitate HCME through storytelling, cultural routes and sustainable tourism, and product development.



DISSEMINATION AND CONTINUATION


INNOCASTLE opens a Europeanwide discussion about the current and future role of HCME in our society, as an important testimony of our shared European identity.



ACTION PLANS


Together with the local stakeholders, each partner will develop an action plan to improve the addressed policy instrument.

A rural estate is a historical, multifunctional, rural or peri-urban entity composed of different parts which was historically managed as a unity and incorporated living quarters.






Relationship with the landscape

Understanding the multifunctionality of a rural estate is important in the management of the estate.

The 'landgoedvenster' is an exploratory tool developed in the Netherlands by the PPO of Wageningen University & Research agricultural business unit amongst others. Through a questionnaire it identifies the quality of an estate relating 7 topics roughly grouped along a People / Planet / Profit diagram. The inherent multifunctionality of rural estates is translated in the objective to have a balanced score on all topics.


"What struck me in this area was the combination of really big and interesting castles and this incredible landscape".






