



#### **REDUCES INTERREGIONAL MEETING SOFIA 10-11 DECEMBER 2020**

TITLE: Circular Economy Business Model - Shared Platforms

OBJECTIVES: The fourth REDUCES interregional meeting will be virtual and it will be hosted by the Bulgarian partners of the project – Euro Perspectives Foundation (EPF) and University of Mining and Geology (UMG). The overall objective of the meeting is to highlight the regional development issue in Bulgaria as reflected in the policy instrument. ## Main points of discussions are:
