

## Mapping of re-use and /or preparation for re-use resources

*N.B.* For a general understanding of the distinction between re-use and preparation for re-use, RREUSE drafted hereunder two definitions, which are not official or legal.

**Re-use**: any operation by which products or components that are not waste are used again for the same purpose for which they were conceived.

**Preparation for re-use**: operations of control, cleaning and repair by which the products or their components that have become waste are prepared to be re-use without further heavy treatment.

**The Danish Environmental Protection Agency manages a number of programmes, where it is possible to apply for grants for waste projects including MUDP, Food Waste and Plastic Packaging.**

**Yes, there are different re-use centres throughout the Region.**

**Firstly, REUSE in Aarhus (administrated by AVA), but there are several other re-use centres in the major cities in the Region.**

*N.B. Re-use centres can be described as facilities where used products or waste products are collected, sorted, checked, cleaned, repaired, stored, sold or subject to any operation by which products or components of products can be re-used without any other pre-processing.*

**REUSE in Aarhus covers around 2000 square meters**

**Yes a lot. All kinds, some owned by private enterprises other by humanitarian organisations. Second hand shops are very popular and have been functioning for many decades.**

**Alone in the city of Aarhus, there are around 15 shops. We estimate between eighty and hundred in the whole region.**

**Most shops focus on fashion/clothes or furniture/retro**

**Except from REUSE there are 6 recycling stations spread out in Aarhus Municipality. In one of the recycling stations there is a possibility to deliver goods to direct recycling (450 tons /year)**

**Q9a. Do they collect for re-use and / or preparation for re-use?**

**REUSE in Aarhus receives on a daily basis more than 2 tons of effects, primarily in containers from the 6 other recycling stations. Furthermore, more than 1200 tons of clothes are collected**
