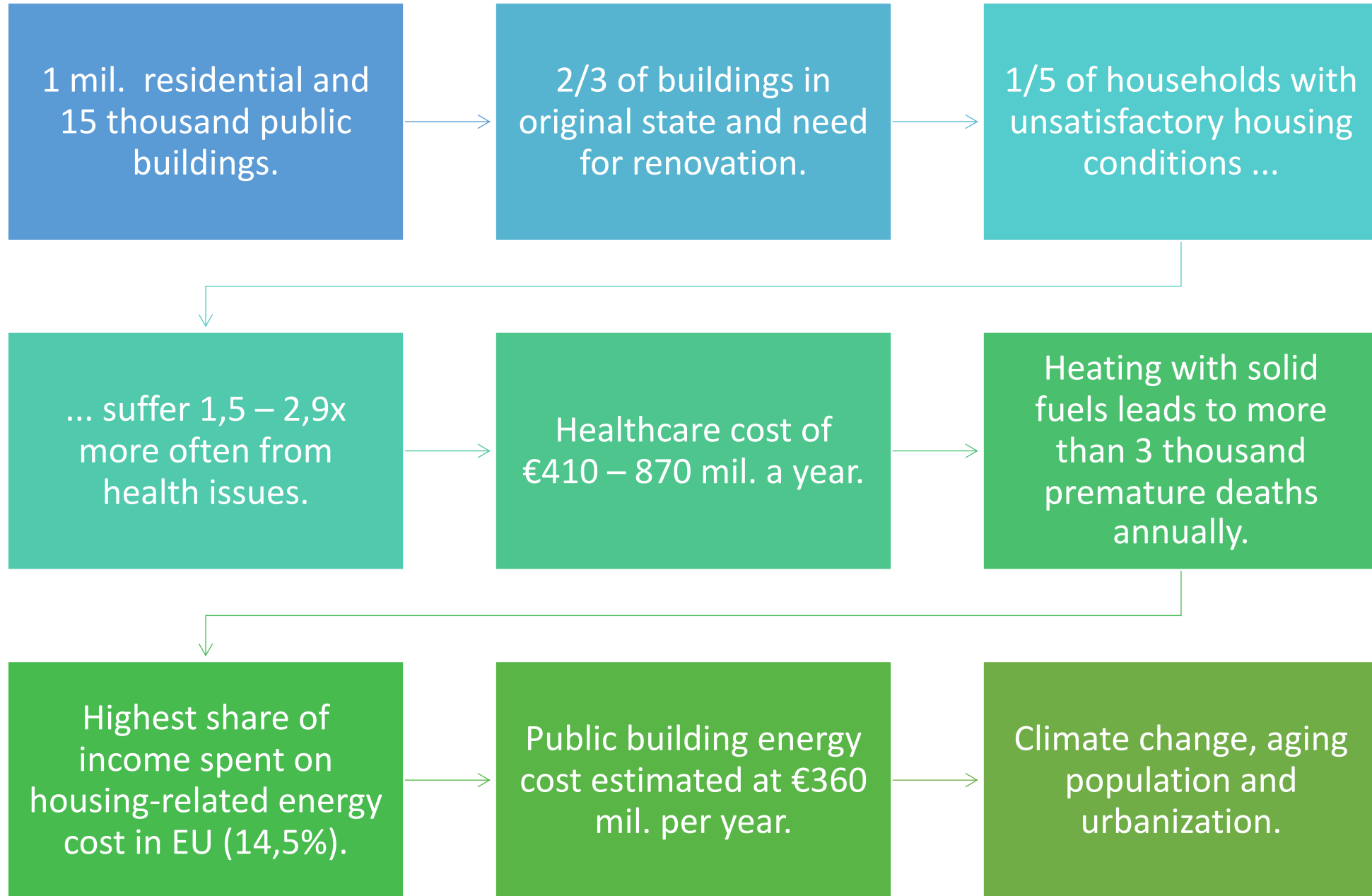

The push of European policies

Carbon Neutrality by 2050

- The key potential of buildings
- 80 % of existing building still there in 2050
- 75 % of existing buildings inefficient

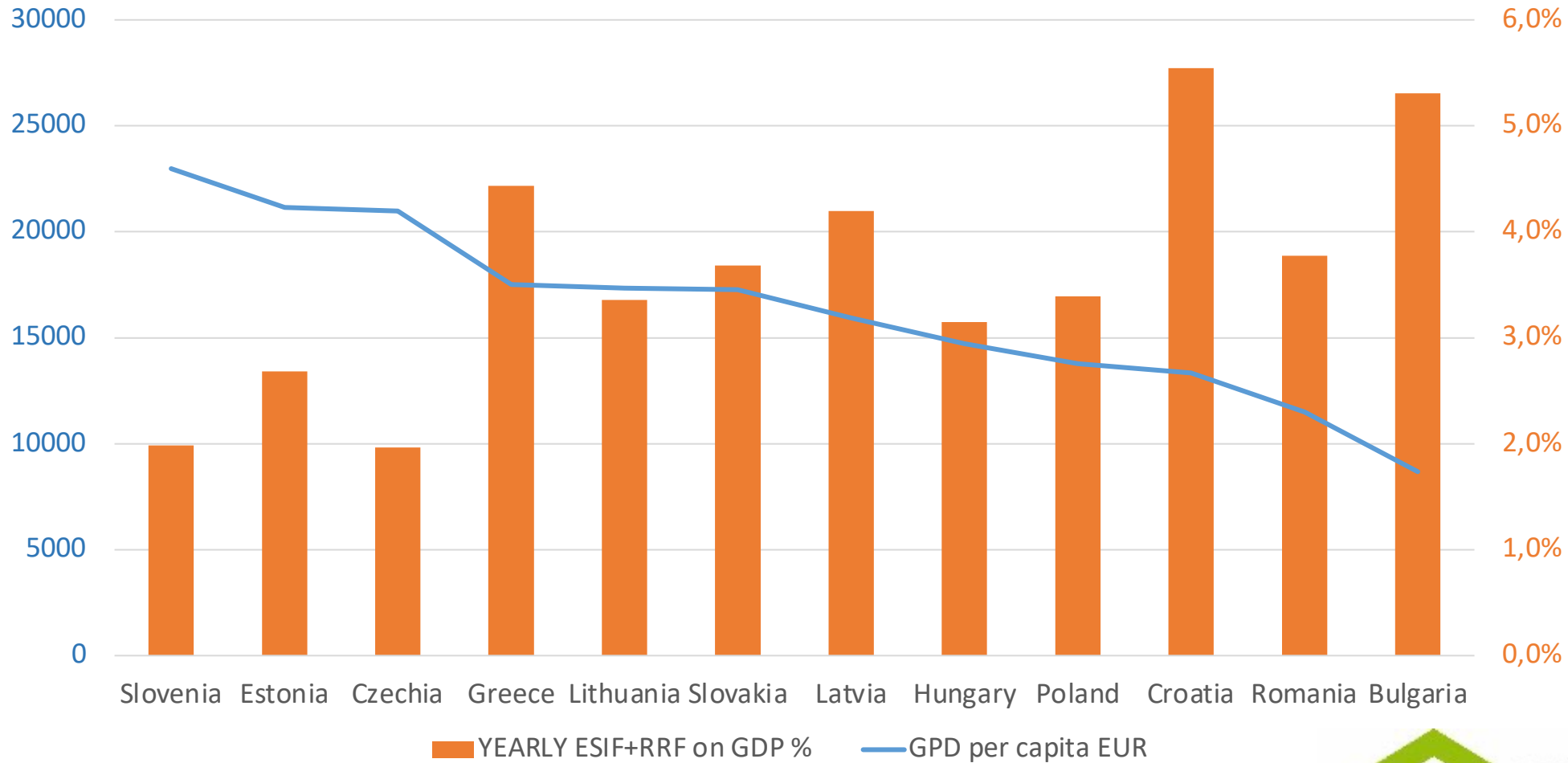
Long-Term Renovation Strategy

- Ex ante conditionality for ESIF 2021 – 2027

Renovation Wave

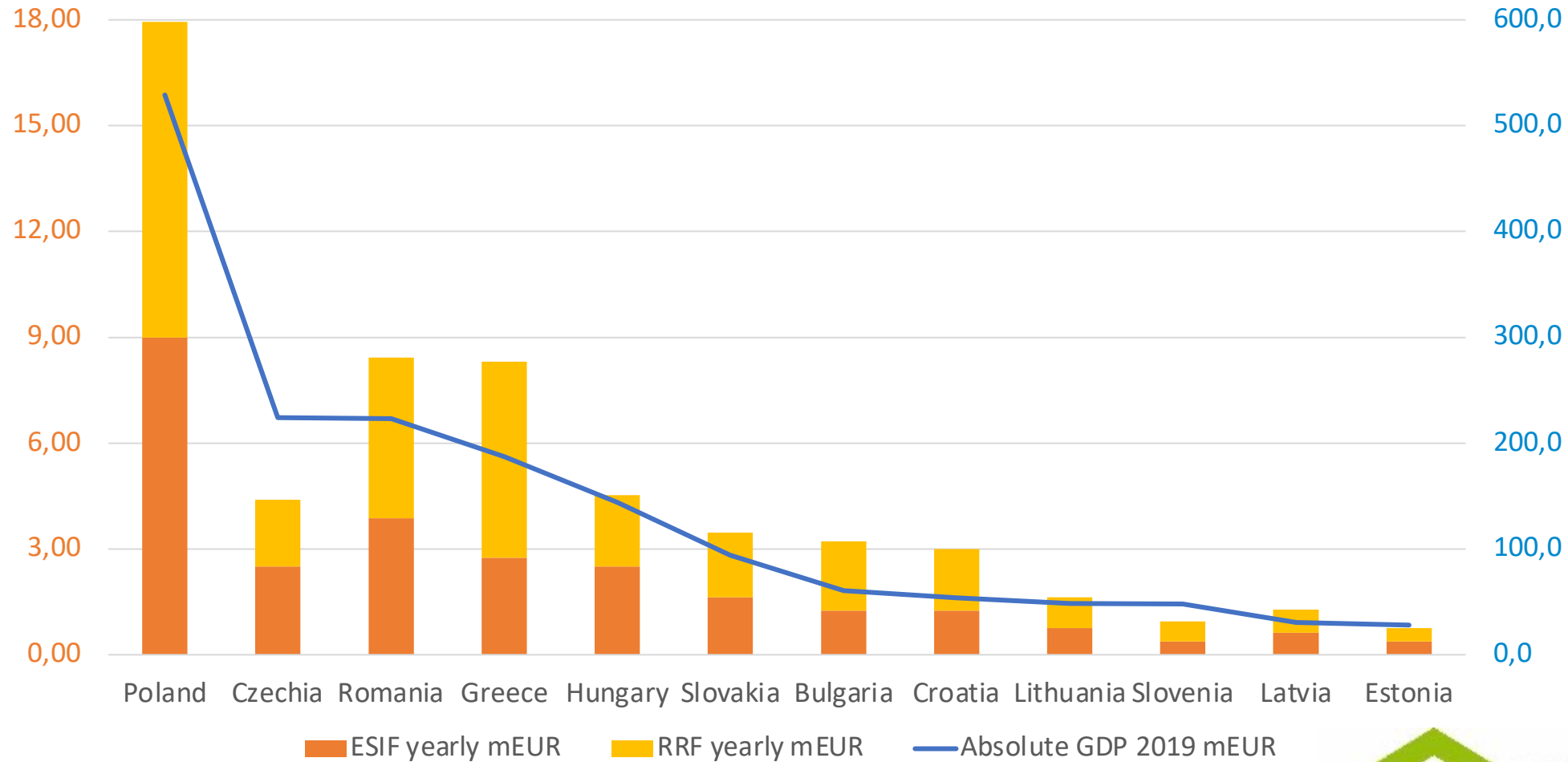
- 23 measures for 2020 – 2024
- Double renovation rate and increase uptake of deep renovations

Government manifesto

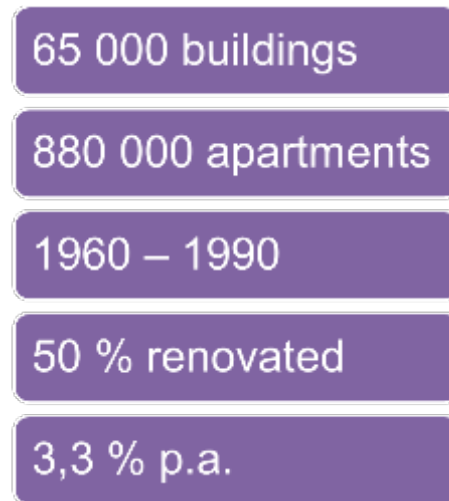
- Support EU climate policies through energy efficient and decarbonized building stock.

Public support

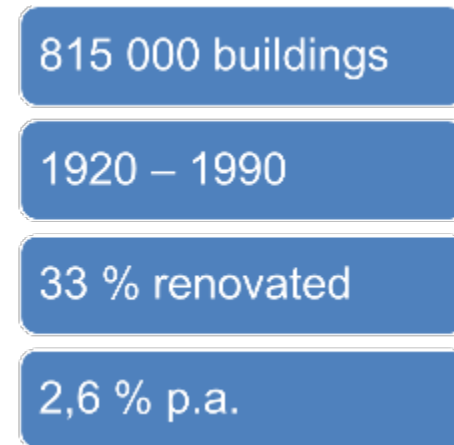
- Public poll, May 2020

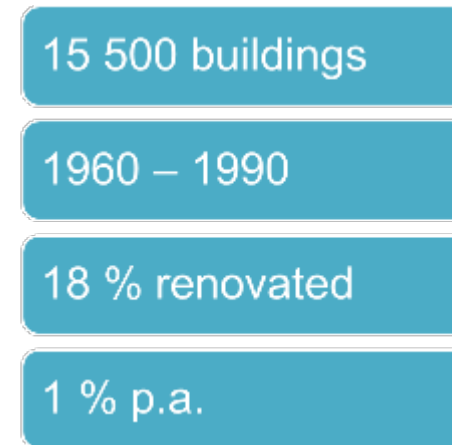

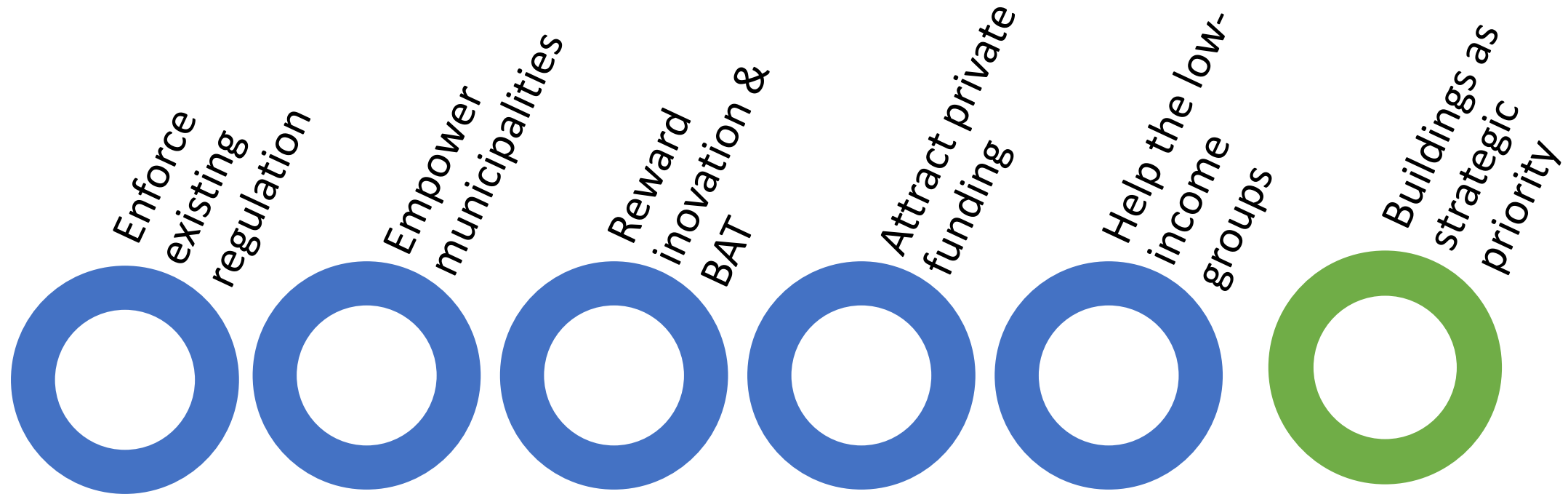
