INTRODUCTION

greatly worsened by the Covid - 19 pandemic emergency, has led Molise Region to explore new measures and economy. The priority requirement is to develop new business models with a great potential in terms of ecosystem to overcome distortions current economic situation. Besides that, the regional entrepreneurial world faced the need to reinvent their businesses in order to survive on the market, moving on products, processes and marketing. A key strategic choice could be the integration of ICT solutions in their creative and opened vision.

As highlighted in the Regional Smart Specialization Strategy (S3), the main regional policy orientation in this context is to support the creation of growth opportunities based on knowledge, innovation and stakeholder sharing processes. This intent can be set by supporting the realization of innovative proposals by SMEs and professionals, in the form of experimental projects based on cooperation, networks and synergies. Specifically, for Molise

Region, the Smart Specialization strategy, identified "the creativity" as one of the development drivers for the region and ICT and it represents an important element for the regional growth. In line with the main aim of the project RegionArts, which is to promote the competitiveness and innovation of companies through the integration and synergies, between ICT and artists, Molise Region Action Plan foresees to offer innovative implement the management of the regional funds, confirming that the Policy Instrument addressed is the Regional Operational Programme (ROP) - Molise Region 2014-2020, as indicated in the Application Form but specifying that, according to the Decision C(2015) 4999 final, the European Commission approved, for Molise Region, the Operational Programme of the European Regional Development Fund (ERDF) along with the European Social Fund (ESF) for the period 2014/2020. It is a unique Programme which includes 11 priority axes, including the Priority Axis n. 8: "Education and Training" (ESF) in addition to those already mentioned in the Application Form and addresses by Molise Region Action Plan.

Enhancing SME growth by the integration of Artists in ICT projects

The RegionArts project has been granted in the framework of the Interreg Europe Programme 2014 – 2020. Category 2. SME competitiveness, Specific objective 2.1. Improving SMEs competitiveness policies. Eight partners are involved in the implementation of the project:

- 1) PDF Porto Polytechnic Institute (Portugal);
- 2) ART-ER StockJoint Consortium (until 30/04/2019 ASTER StockJoint Consortium) (Italy);
- 3) Baltan Laboratories (The Netherlands);
- 4) KEPA Businessand Cultural Development Centre (Greece);
- 5) SERN (Startup Europe Regions Network) (Belgium);
- University of Lapland (Finland);
- 7) ENTER Koprivnički poduzetnikLtd. BusinessSupport Institution (Croatia);
- 8) Molise Region (Italy).

The main general objective of the project is to improve the implementation of Structural Funds/other funds in partner regions, through adapting or designing 1 support scheme in each region for the promotion of collaborations between artists and ICT companies. About Molise Region, the participation in the project has facilitated the improvement of the Governance process on the basis of the RegionArts outputs, as developing a monitoring mechanism to evaluate impact of regional development on ICT

Tools adoption and through a better Public Administration staff capacity, achieved during the participation in the project learning process. Moreover, an improvement of the addressed policy instrument has been led by including synergies among ITC & Arts as an eligible expenditure and a strategic activity in the financial and non-financial instruments implemented.

The implementation of the project foresees two phases:

- 1) Phase 1 Focus on the interregional learning process (from June 2018 to May 2021). During this phase, an interregional learning process has been conducted through the exchange of experiences (EoE) and study visits among partners. At the end of this phase, each partner, included Molise Region, must submit an Action Plan for the integration of the lessons learnt into their local policies and practices.
- 2) Phase 2 Monitoring of the action plan implementation (from June 2021 to May 2023). In this second phase, the RegionArts partners will be asked to monitor the implementation of their own action plans.



OVERVIEW

Molise Region - The policy context about ICT and the Arts.

Nowadays, in Molise the experiences of connection between policy makers, entrepreneurs, researchers, developers are sporadic and occasional and a structured system to encourage this kind of collaborations is not present on the regional territory. The reasons for this lack are several, first of all a poor entrepreneurial culture and a really low number of graduates in technical and scientific disciplines, as well as a poor endowment of telematic infrastructures and a lack of coordination and availability of local actors for participatory and cooperative actions. But also, a weak awareness of the opportunities for SMEs' growth and innovation arising from the

vcooperation among ITC and arts by the side of Molise Region policy makers can be underlined.

In the framework of the RegionArts activities, Molise Region implemented a mapping process in order to support its policy on Research and Innovation, mainly through ROP ERDF/ESF 2014-2020, based on actions dedicated to RIS3 implementation that can contribute to the regional strategy implementation and actions coherent with the RIS3, strongly connected with the topic addressed by RegionArts project.





With the project activities a dialogue was started between the official representatives of the regional offices of the Ministry of Cultural Heritage and Activities, the professors of the University of Molise and research centres, representative of professional associations, in particular Architects and Engineers, representatives of Municipalities, Schools, Organizations and Cultural Associations in order to create a structured operational network able of stimulating institutions towards shared and feasible solutions that allow the use of culture and creativity as a driver for social and economic innovation

and as a stimulus for research and investments in the field of technology and innovation.

This important connections among ICT, arts, cultural, tourist and creative industries is mainly recalled in the Molise Specialisation Strategy which Smart underlines, as development drivers and vertical and horizontal interventions, just the involvement of the cultural, tourist and creative industries and innovation in the ICT system and, as development driver just the creativity sector, in line with the RegionArts topics.

Molise Region would like to improve its policy instrument by including synergies among ITC & Arts as an eligible expenditure and a strategic activity in the financial and non-financial instruments

to be implemented within the ROP ERDF/ESF 2014/2020 of Molise Region. Our Policy makers have a weak awareness of the opportunities for SMEs' growth and innovation arising from the cooperation among ITC and arts, so for them it is hard to shape the policy instrument.

As planned by the Interreg Europe Programme, in terms of results, each action planned in the Action Plan must improve the Policy Instrument/ Structural Funds programmes addressed in 3 different ways, that can be also interconnected:

- 1) Type 1: implementation of new projects;
- 2) Type 2: change in the management of the policy instrument (improved governance)
- 3) Type 3: change in the strategic focus of the policy instrument (structural change).

Molise Region with its Action Plan aims at making results in changing management of the policy instrument as improved governance (Type 2), integrating some learnt experiences, gained from the RegionArts interregional learning process led during the phase 1 of the project. These new inputs allowed to Molise Region to reconsider the evaluation grid of an already launched public notice for the presentation of new projects of higher education courses, in order to assign more scores to the projects which consider the RegionArts themes and topics in their submitted proposals.



ACTION

Identification and planning of postgraduate training courses.

THE BACKGROUND

Molise Region gained awareness that the basis for growth and the achievement of good results in this field must be the identification and planning of higher education and training activities that can promote the integration of the creative sector within research and innovation in Molise ICT sector

In Molise, the current state of the art regarding the technical knowledges and skills about artistic and creative processes in the framework of the innovation sector, especially in the Information and Communication Technology (ICT), suggests that the sector must be strongly promoted and enhanced. From the experiences acquired:

a) in the Study Visit held in Bologna on 1-2 October 2018, organized by the partner "ART-ER StockJoint Consortium (until 30/04/2019 ASTER StockJoint Consortium)" where the partnership visited the "Fondazione Golinelli" and gained information about the project "Icaro", dealing with the developing personal growth and bridging the gap between study and working life;

b) in the Exchange of Experiences (EoE) n. 5 held in Brussels from 4th to 8th November 2019, where the good practice "Kratkispoj (Short Circuit)", coming from the partner 7 PP "Koprivnički poduzetnikLtd. Business Support Institution" of RegionArts, was presented, and from the detailed description of this good practice inserted in official page of the RegionArts project; Molise Region gained awareness that the basis for growth and the achievement of good results in this field must be the

identification and planning of higher education and training activities that can promote the integration of the arts, and more generally, of the creative sector as an essential and fruitful component within research and innovation in Molise ICT sector.

Specifically, the basic purpose to enable students to work in an interdisciplinary, cross-sectorial context, highlighting the connection of the art S area with the technical and professional sector inspired the development of this action. Moreover, the "Short Circuit" project offered to the students the change to integrate theoretical knowledges in the art sector with practical experiences, involving students of different professional and scientific backgrounds. In order to transfer the above-mentioned experiences in a practical manner also on the Molise territory, this Action 1 focuses on the integration in the evaluation grid of an already launched Public Notice called "Post-graduate courses and Territory.... My future in Molise" in the framework of the ROP ERDF/ESF 2014/2020 of Molise Region. This Public Notice has been structured from the beginning considering two deadlines to submit proposals during the year 2020 but at the same conditions.

Art. 1. Finalità dell'Avviso

Starting from the importance of transferring this acquired best practices and learnt lessons, Molise Region put in place the following actions in order to integrate the Public Notice with references to the RegionArts project and the importance to valorise the proposals that allows to enhance the synergies between ICT and arts/design/creativity between artists and professionals, creative people and ICT technicians, humanities and sciences students:

- a) several meetings with the ROP ERDF/ESF 2014 2020 of Molise Region Managing Authority;
- the official note n. 127239/2020 of 10.08.2020 sent by the Director of the Molise regional Service "Competitiveness of Productive Systems, development of Industrial, Commercial and Crafts activities, competition policies, internationalisation enterprises, European territorial cooperation and territorial marketing", in charge of the RegionArts activities, to the Managing Authority for asking the to assess the opportunity to integrate the Public Notice considering references that enhances of high education paths that allow to improve the synergies between ICT and art/design/creativity between artists and technologists, between creatives and computer scientists, between humanists and science scholars:
- c) the regional determination n. 112 of 21 September 2020 that approves the modification of the evaluation grid of the proposed projects of high education paths;
- d) the new version of the Public Notice that reports at Article n. 1 "Purpose of the notice" the references to the RegionArts project as follows:

"In this context, the intention is to finance the creation of high-level training courses, which should also be consistent with the Smart Specialisation Strategy (RIS3) providing a strong link with the economic realities of the area. In line with the Smart Specialisation Strategy, as well as with the comparison, experience and good practices related to the European project RegionArts - Enhancing SME growth by the integration of Artists in ICT projects', there is a willingness to support high-level training courses that also allow cross-sectoral learning that favours the interconnection between the humanistic and the technical/scientific spheres, which are no longer separate if we want to cope with the new transformations that the digital is imposing to the world of work and culture".

- e) the modified evaluation grid for valorising the proposals connected to the Smart Specialisation Strategy (S3) that must take into consideration also the connections between the presented projects and the valorisation of the technological innovation connected with the art and culture, as suggested by the RegionArts learning, considering 5 more scores for those projects which presents "complementarity with objectives/actions in other regional programming documents (coherence with strategies/objectives of regional programming documents, in function of the overall socio-economic development of the territory)"
- comparison between the evaluation of the proposals submitted in the 2 different deadlines, referring to the new score added thanks to the influence of RegionArts, showing that, in the submission of the applications of the second deadline, many projects considered to include elements deriving from RIS 3 and the topics of Regionarts in order to improve their proposals, which made the scores, in the reference indicator, but also as a total about the coherence of the proposal with the RIS3 of Molise Region connected to the theme of RegionArts project, much higher than in the evaluation grid of the first deadline.
