





3. Interreg Europe 2021-2027

No revolution...but evolution

Key features remain:

- 1. Pan-European
- 2. Similar overall objective: Regional development policy makers as core target groups
- Similar means to achieve the objective: Main focus on capacity building



Evolution:

- 1. Focus on Structural Funds lightened
- 2. Learning by doing: pilot actions
- 3. Only one single priority in the programme to better reflect the core nature of the programme (capacity building)

Timetable for 2021-2027

• February 2021: PC approved draft Cooperation Programme

Spring & summer 2021: final approval by Partner States

Approval by EC expected early 2022
