Financing system in Thessaloniki

Thessaloniki is currently formulating its Strategic and Operational Plan for the years 2019 – 2023. Although it should have been finished by now, this was not possible due to the pandemic and, also, the lack of the relative legislation that did not get published so far.

Funding sources

- European Regional Development Funds (ERDF 2014 2020)
- European Regional Development Funds (ERDF 2021 2027)
- Recovery and Resilience Facility (RRF) Greece 2.0
- Public Investments Fund (PIF), (i.e., Filodimos I and II Programmes): This can prove a very useful tool, especially in maturing ideas. However, it requires strenuous negotiations between the central governance and Public Local Administrations.

Financing system in Thessaloniki

Funding sources

- Antonis Tritsis Development Fund (AT): this fund is a loan of the central government with the EIB. It funds several types of actions such as electric cars, public space interventions, upgrades of public buildings etc. MoT has submitted proposals of a total budget of more than 50 mil. €.
- Electra Fund (EF): Interventions indicatively related to the building shell, in the various systems of Electro-Mechanical installations and interventions that have proven to contribute to the energy upgrade of the buildings, including the static reinforcement, where required
- **Green Fund** (GF): It is a national fund that provides funding for actions relative to greening of public space, electromobility and others
- Public Private Partnerships (PPPs)
- Loans (European Investment Bank): MoT has acquired a loan of 20 mil
 € from the EIB, co-financed with 7 additional mil € from the PIF. It is likely that a new contract will be signed once the current one is finished
- Own (Municipal) Resources: This mainly refers to Reciprocal fees given back to municipal lighting




