Development Centre of the Heart of Slovenia (DCHS) organized the 2<sup>nd</sup> Regional Multi-stakeholder Group meeting (RMG) on 24<sup>th</sup> August 2022 in Kamnik. We have joined again with the workshop on our LAG project “Point for Elderly”, since all local stakeholders are the same. The project manager, Anita Molka presented comments on draft regional analysis and discussion was on the update. She also presented the Agenda of the conference/workshop in Bucharest (20.-21.9. 2022) and invited interested stakeholders. After discussion they all agreed that the most suitable stakeholder to attend the meeting in Bucharest is Ministry of Health.

In the 2<sup>nd</sup> part of the stakeholder meeting, Martina Ozimek presented the mission and activities of Association Oreli as one of the Good practices in Home Care, that was very suitable in Covid-19 crisis.

### **CONCLUSIONS OF THE MEETING**

DCHS informed all stakeholders that we will keep them updated on HoCare activities and that we will do our best to actively include Ministry of health, so changes can be done on national level. Since in Slovenia there was a change of government, Long-term care Sector was not re-established yet and we needed to wait. Now they established office for Long-term care that is directly under the Ministry. As agreed they were invited to the final conference and Marina Bevanda from The Ministry of Health, Office for long-term care, will attend.
