1) Updates on HoCare Project – Actions to be taken

Ferenc Weigl project manager of National Directorate General for Hospitals (NDGH) working in the HoCare project welcomed participants on the occasion that the project has been prolonged for an extra year. The new exchange will be based on the flow of the HoCare project's 1st Phase's activities phase activities. The objective aim is to address the impact of the crisis and the pertaining tasks, including the preparation of 1 regional report per project partner (PP) to measure and estimate the impact of the COVID-19 crisis on the delivery of innovative home-care solutions, in line with the smart specialization strategies of the partner regions.

2) Brief Presentations

István Csizmadia of the NDGH informed stakeholders that potential best practices or solutions that proved to be effective responses and could be incorporated into regional/national policies, would be further collected to decrease the impact of COVID-19 crisis in social and health care services. He underlined activities that would include preparing a Regional Report containing information collected from the region about the status of Home Care R&I and the status of quadruple-helix cooperation in the sector. He stressed the importance of identified Regional Good Practices that would serve as the basis of the new exchange of experience process on the crisis impacts and on possible measures to face and recover from the crisis.

Zoltán Bendó, Liontária Ltd. who was a participating expert in the elaboration of the Hungarian HoCare Regional Action Plan brushed up and highlighted those policy recommendations and financial engineering instruments, meant to strengthen regional innovation chains and boost innovative services and products in the field of homecare, and therefore could increase the effectiveness of the implementation of EDIOP.

Katalin Barna, Head of Unit from the Ministry of Finance, informed talked in details to participants about past experience with EDIOP calls for proposals and as well as the new possibilities arising from the new Economic Development and Innovation Operative Programme Plus (EDIOP+) currently under elaboration.

3) Round table discussion

The discussion also involved the topics of implementation of the original HU Regional Action Plan and the review of the Policy Instrument Report submitted previously. RMG members were involved in the making of the HU RAP. However, the Policy Instrument Report was new to them, and were not yet familiar with its content. The discussion also touched upon the selection of further best practices. RMG members were of the majority opinion, hence advised that less but more valuable HU practices would be selected, i.e. selecting only a few in terms of numbers but those, which would really impress project partners and would prove to be very attractive at the same time, let alone easy and quick to transfer.

4) Concluding remarks – Next Steps:

Based on the discussion, the following actions/steps are proposed:

Selection of new best practices;

Preparation of description sheets;

Preparation of the first draft of the new regional report;

Convening the next RMG meeting with introduction and discussion of new best practices (the 'what's and 'why's) as well as on the draft report;

Finalizing the report.
