## Focus group description

Due to the large number of events that took place in September on topics such as health care, ehealth, and others, we decided to go the way of cooperation with Jan Evangelista Purkyně University and the Innovation Centre of the Ústí nad Labem Region (ICUK) and implement a focus group at a joint event that took place in the Ústí nad Labem Region where ICUK is located. However, since not all those who were part of our first Focus Group attended the event, we decided to send the final report to these experts by electronic means in order to inform all those involved with the results of our survey.

At the meeting of regional stakeholders led by UJEP, the measures from the previous workshops and the proposal of a regional action plan for the D-Care project were discussed, followed by Vojtěch Jira (DEX-IC) presenting the project Innovation in Home Care HoCare, which also included an interesting presentation by Yvonne Prinzellner (Johanniter, Austria) of the WAALTeR project, which also falls thematically in the field of home care, however, it was a presentation of good practice from neighboring Austria.

**1) Opening/welcoming** – at the beginning of the meeting, the representatives of UJEP welcome the participants. During a short intro presentation, the agenda and presenters was introduced.

**2) D-Care** – In the framework of the D-CARE project workshops we discussed the actions from the previous workshops and finalized the draft of the regional action plan for the Transnational Strategy for the Development and Implementation of Service Models for Intelligent Care for the Elderly.

The regional action plan is more narrowly focused on creating conditions for digitalization and implementation of innovations in social and health services (smart care), in terms of binding character it has the character of recommendations from regional actors and should help to implement the measures within the Medium-term plan for the development of social services of the Ústí nad Labem Region and community plans.

The thematic delineations (pillars) are jointly defined to the trans-regional strategy to develop smart care across 8 different countries participating in the implementation of the D-Care project (Interreg Danube).

**3) HoCare ext. project presentation** – The main idea of the original project and its extension were presented. The participants were introduced to the implementation of the follow-up activities of the extended project and received information on the project activities related not only to the elaboration of the regional report.



The main aim was to present the outputs not only from the Czech regional report, but also to show interesting examples of good practice that facilitate the daily life of caregivers.

During the presentation, we were able to describe the current situation of research and innovation in the field of home care and the reasons for renewing the project partnership established in the original project, which aimed to describe the impact of the COVID pandemic on home care.

The presentation provided information on the government's response at strategic level, where many new strategies have been developed (or updated in response to the COVID situation) and subsequently approved by the government.
