PRELIMINARY PHASES

- January 2022: started the **discussion** with the Department of the Ministry for Cohesion policies (DPCoes)
- March 2022: the Province of Trento **defined the areas** to be selected within the Italian Strategy for Inner Areas for the programming 2021-2027.



The DPCoe, with the support of the Evaluation and Analysis Unit for Programming (NUVAP), verified that the proposed areas were in compliance with the **criteria** envisaged for the selection of the new Inner Areas. These analysis considered:

- the coherence of the area proposed with the Inner Areas map;
- the identity and/or geomorphological element defined and recognizable of the area;
- the demographic trend of the area;
- the organization and use of essential services of the area;
- the capability and willingness of the municipalities of the areas to associate;
- the dimension area in terms of number of inhabitants and municipalities.



Finally, the **negotiation phases** between authorities of the areas, the Province of Trento and the Government was carried out and the **areas approved**.

ACTION PLAN ACTIONS

As expected by the shared programming, the Province of Trento defined and improved, in terms of participation and negotiation, the policy of **STRATEGY FOR THE INNER AREA OF VALLI GIUDICARIE (CENTRAL AND EXTERNAL)**

INVOLVEMENT OF ADMINISTRATORS OF THE INTERESTED MUNICIPALITIES (INFORMATIVE, TRAINING MEETINGS) to raise awareness in terms of opportunities and necessary innovation actions

- ✓ 3 meetings in the area (mayors, secretaries of the municipalities and relevant stakeholder at institutional level, 50 people)
- ✓ Identification of a Leader (Municipality of Tione)
- ✓ Identification of a representative of the municipality within the Provincial Technical Governance Committee and of the planning group
- ✓ Meeting of the planning group with the Province of Trento for the definition of activities, schedules, elaboration of strategies and how to involve citizens and stakeholders

INVOLVEMENT OF CITIZENS

- ✓ Involvement of citizens with institutional communication from each municipality and request of compiling an online questionnaires (needs, interests, orientations)
- ✓ Questionnaire results will be elaborated in a working paper and a first draft strategy to be discussed with the representatives of entrepreneurs /trade unions and the most relevant stakeholders
- ✓ Focus groups will be organized: HEALTH, EDUCATION, MOBILITY

3 **STRATEGY PROPOSAL AND NEGOTIATION**

- ✓ Focus group: the project group discusses the strategy with the Provincial Governance Committee
- ✓ Submission of the strategy proposal to the Central Department for a further negotiation
