THE POLICY INSTRUMENT

The STRATEGIC AGREEMENT ON OCCUPATIONAL RISK PREVENTION 2022-2026 of Castilla-la Mancha

- Signed on April 28th, 2022
- Signatories: regional government, trade unions and employers
- Objectives:
 - Reduction of accidents at work is the main priority
 - Promotion of safe and healthy workplaces
 - To raise awareness in Castilla-La Mancha about the importance of Health and Safety at work as a crucial component of quality of life, promoting a cultural change by different means
- The measures of the Agreement are divided into 3 axes:
 - Dissemination,
 - Promotion and
 - Surveillance
- Estimated budget: 29,5 million euros distributed from 2022 until 2026



Action plan

➤ Why this PI?

- Health & Safety at work is a multifactorial issue with a strong need for collaboration between multiple actors
- Many stakeholders with different levels of participation, priorities, means and competences
- This PI is led by our administrative unit (the Vice-Ministry of Employment, Social Dialogue and Labour Welfare)

➤ ACTION PLAN PHASES

- PHASE 1: Dossier development
- PHASE 2: Localisation and identification of stakeholders
- PHASE 3: Presentation of the findings achieved in the project and interaction with 16 stakeholders (November 2022- April 2023)
- PHASE 4: Project follow-up (under development)



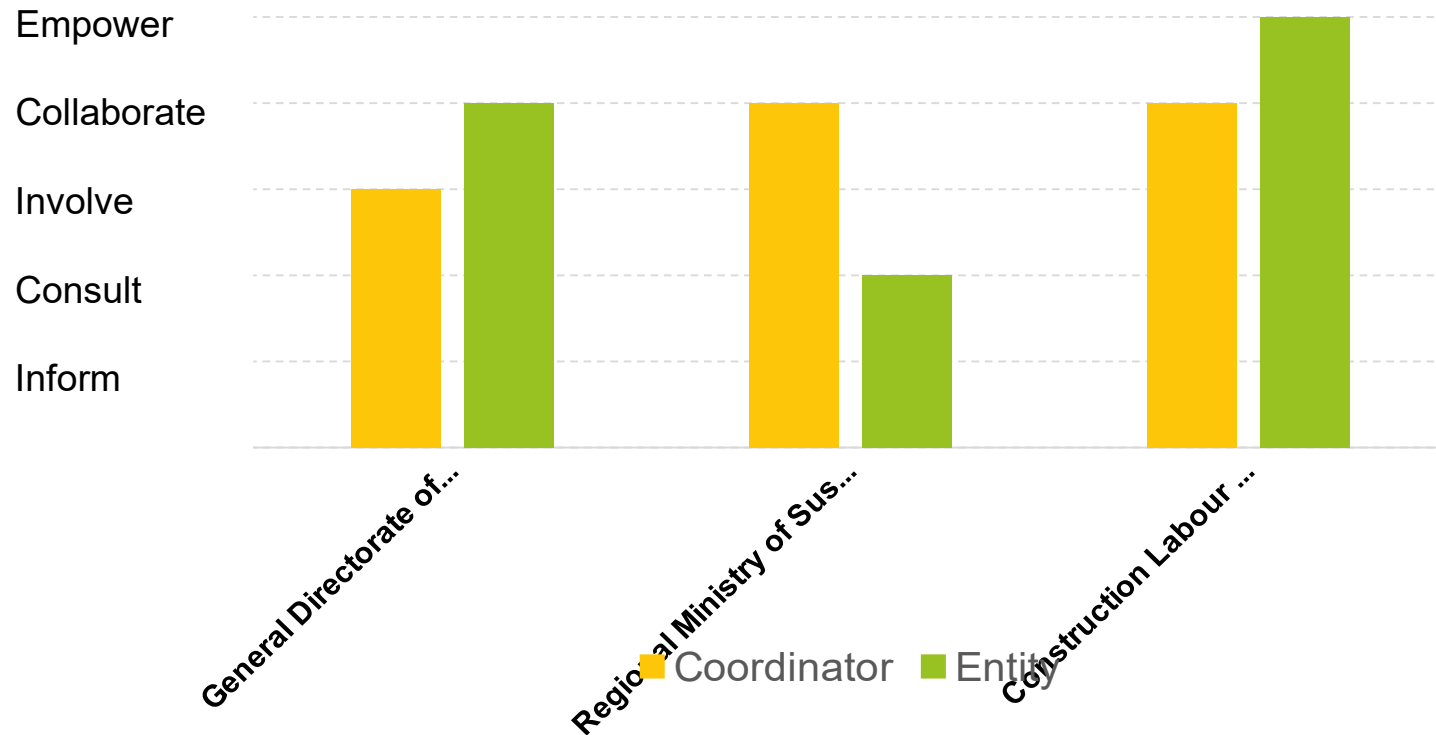
