Limited number of regions exchanging and transferring experience on a shared regional development issue










Concentration principle (80%)

First call for proposals

- Open from 5 April to 31 May 2022
- 134 proposals submitted
- 72 projects approved





Second call for proposals

- Open from 15 March to 9 June 2023
- All topics open
